- 1) CALL TO ORDER: The Special Meeting of the Balaton City Council was called to order at 6:01 pm on Tuesday, August 26, 2025, by Mayor Lonnie Lambertus.
- 2) ROLL CALL:
 - Present: Mayor Lonnie Lambertus; Council Members Tracy McCloud, Greg Erickson, Dylan Fricke, Curt Paradis

- 3) Fencing: Torgeson stated when people want to put up fencing, they bring in a drawing with their zoning permit and he lets them know the setbacks. A resident explained what they were going to build a fence out of to hide their backyard. The materials will cause neighbors to complain the same as not having the fence at all. It was suggested that when turning in a zoning permit there should be a spot to write down what materials will be used. McCloud asked how we amend our ordinances, and it was explained that we have a public hearing that's posted for 10 days and then it can be amended. Lambertus said he would get ahold of Matt Gross to have him write something up for the City Code.
